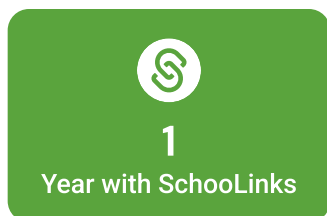
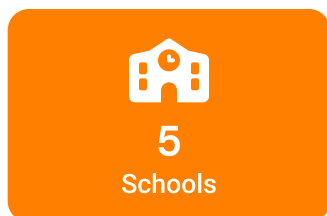
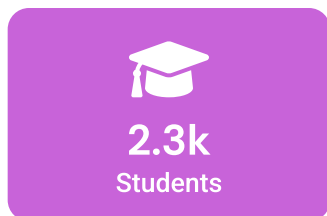




Why Tipp City Exempted Village Schools

# Said “Goodbye” to Naviance and “Hello” to SchoolLinks

Tipp City Exempted Village Schools was serious about improving the college and career readiness process for all stakeholders.



## The Problem: Needing a New College & Career Readiness Platform

With disappointing results working with Naviance, Tipp City needed a platform that would allow them the flexibility for tracking student academic plans, graduation requirements, and student seal progression.

## The Solution: Embedding SchoolLinks into Several Workflows

Onboarding educators, school counselors, and students required getting everyone involved. Once professional development was provided, staff and students could run with the variety of solutions SchoolLinks offers.

# The Problem

## Needing a New College & Career Readiness Platform

In Ohio, all districts are expected to track and report on every student's graduation plan and document how they will meet graduation requirements. Tipp City Exempted Village Schools used Naviance to track academic course plans. When Ohio added new requirements for monitoring and tracking seals in the graduation requirements, Tipp City looked to Naviance to help meet the expectations. Unfortunately, Naviance did not and was unwilling to provide the support needed to track graduation seals per Ohio's expectations effectively. Therefore, Tipp City needed to begin the search for a new college and career readiness platform that would meet the needs of students and state regulations.

Word across the district spread among departments about SchooLinks as an improvement compared to the Naviance experience. Several neighboring districts shared their positive experiences of transitioning from Naviance to SchooLinks. They cited the usefulness of the platform and the resourceful team members that guide the implementation as the reason for SchooLinks' success. After hearing such positive feedback, Tipp City leaders decided it was time to switch.

SchooLinks met with district and school leaders to discuss the need for supporting students, helping improve workflows for school staff, and providing reporting on academic plans and seal requirements. After an extensive review of the SchooLinks solutions, the district was eager for the opportunity to scale its services to reach more students and collect the necessary data required to track Ohio graduation plans.

# The Process

## Embedding SchooLinks into Several Workflows

Tipp City was prepared to officially implement the modernized college and career readiness platform with their middle and high schools. Early on, teachers identified opportunities for using SchooLinks to enhance classroom instruction. Career Connection teachers began leveraging the learning units in SchooLinks. Additionally, the technology teachers began embedding the SchooLinks lessons into the personal finance course.

For school counselors, the college application process was made easier with the SchooLinks Common App integration. School counselors praised the in-platform instructions that gave students a step-by-step guide for completing the Common Application and linking to SchooLinks. Counselors noted that SchooLinks saved them time from having to provide technical support and training for educating students and parents on this critical aspect of the college application process.

A significant reason for choosing SchooLinks was for its Course Planner to help meet the state requirements of every student having a four-year academic plan and track all student seals for graduation requirements. Tipp City discussed their appreciation for the SchooLinks team for working closely to ensure that the product was flexible to meet the needs of their students and creating a course planning tool that could easily manage to track all student seals.
